Most residents will be aware that on Wednesday 21st March the Secretary of State announced his decision to allow the Appeal by Berkeley Homes and the Howard of Effingham School. This is a terrible blow to the village. Residents were overwhelmingly against the planning application and Guildford Borough Council (GBC) had rightly refused it in March 2016. Our Parish Council took part in the Appeal Hearing in May 2017. Their witnesses and Barrister presented a very strong case for the village and EFFRA emphasised the village's overwhelming opposition to the development.

The Secretary of State agreed with the Planning Inspector's recommendation that the Appeal should be allowed as he ruled the poor condition and suitability of the school buildings and financial constraints constituted very special circumstances. In addition, he saw the 295 new houses as a major benefit because Guildford only has a 2.1 year housing supply and a record of chronic under-delivery of housing. This seems to follow Government guidelines that housing appeals should be generally allowed where an area, like Guildford, does not have a five year housing supply and does not have an up to date Local Plan.

Effingham can feel badly let down by its local authorities – Surrey County Council which is responsible for school maintenance and rebuilding and GBC for its delay in replacing the out of date 2003 Local Plan, but most of all by the Government with its worthless promise to protect the Green Belt. The report states this is the first time an entire new school has been permitted to be rebuilt wholly funded by enabling housing on the Green Belt. This sets a completely new precedent and is a major threat to the Green Belt. Although the leader of GBC has said that they will "explore the options available" (ie a judicial review) and engage with Effingham Parish Council, these are notoriously expensive to mount and not often successful.

If this large development goes ahead it will be important for the Parish Council, EFFRA and residents to put pressure on GBC and the developers to ensure that the construction work and traffic is carefully controlled to minimise disruption and that the highest standards are demanded for the design of the scheme including the houses and school and the infrastructure, particularly traffic and parking. Overleaf the outline of the scheme and the planning process to be followed is explained.

BERKELEY HOMES/HOWARD SCHOOL DEVELOPMENT

WHAT HAS BEEN AGREED

Permission has been given in outline for the entire scheme:

- the erection of a replacement secondary school for Howard of Effingham (HoE) and up to 258 residential dwellings on the site of the current school and the land at Effingham Lodge Farm owned by Berkeley Homes – access agreed but design and conditions still to be agreed
- the erection of 37 dwellings, with access, parking and landscape works on land at Brown's Field, Brown's Lane for which full permission including the design has been given.

POSSIBILITY OF JUDICIAL REVIEW OF DECISION

Guildford Borough Council (GBC) has six weeks from the date of the decision – 21st March 2018 to apply for judicial review in the High Court ie by close of 1st May 2018

THE TIMESCALE AND PROCESS IF IT GOES AHEAD

Building work cannot start straight away, but the timeframe set by the decision is quite tight and it appears that the whole development may be completed within ten years.

Full permission has been granted for 37 dwellings on Browns Field but a condition is that it cannot begin until the sports and recreation facilities at the new HoE school are completed and in operation. The design and layout of the sports hall and layout of the fields have to be approved by GBC first. In the current outline plans they are part of the main school buildings and it would be difficult to build the sports hall in advance of the rest of the school buildings. There would also be safety issues for them to be used whilst building work was ongoing. Browns Field may well then be the last site developed which was why the Planning Inspector set a longer date for it to have to be started – within seven years of the decision date ie. by 21st March 2025.

Details of the appearance, landscaping, layout, and scale for the existing HoE and Effingham Lodge Farm sites have to be submitted to GBC within three years of the decision date ie. by 21st March 2021. Other matters such as infrastructure and ecological concerns also have to be agreed. The building work then has to begin within two years of approval of these by GBC.

The first site to be started will therefore probably be Effingham Lodge Farm where it is likely that both school and school fields and the expected 159 dwellings will be completed well before the seven years limit to meet the date for work to begin on Browns Field and to let work begin on the existing school site (expected 99 dwellings) within the time frame specified.



KGV Toddlers' Playground Appeal

Over £11,800 (including Gift Aid) has been raised by the Appeal since it was started by four local residents in December. This is over 60% of the £18,000 target set.

The sponsored Welly Walk held on Saturday 10th March has currently raised over £600. It was a fun morning and the weather, less than a week after the snow, was kind. After the walk the children were able to enjoy soft play kindly provided by Emma and Catherine of the Little Bookham & Effingham Preschool which they run at the KGV, who also helped organise the Walk. The children's parents and other residents enjoyed coffee and donated homemade cakes. They were also consulted about what they would like in the playground. Parents and residents can still contribute to the consultation which is available at Loolabells.

The organisers would like to thank residents for their generous donations and ask them to continue supporting the Appeal as there is still a way to go to meet the target.
