## 2.0 Public Meeting

- 2.1 Planning report and issues
  - --- **Berkeley Homes/ Howard application:** A resident spoke in favour of the application, citing, very cramped conditions, scheduling of playground time, poor facilities and need for new homes. Chris Dick and Paula Moss responded quoting facts on which objections have been based, including the audit on the school buildings.

The current GBC Local Plan is out of date and the new Plan is in course of production. The new draft Plan will issue for consultation at end 2015 at earliest. The VNP will give a unique opportunity to influence the GBC Local Plan. The VNP will be subject to a referendum of the village. The current timescale is to submit the draft emerging VNP to GBC by end July 2015 and final draft before end of year 2015, but target around Sept./Oct.
